Marijana Bađun, took her first degree at the Economics Faculty in Zagreb in 2001, and since 2002 has been enrolled in the Economy and Development graduate course. She has done post-graduate work in Prague in the American Institute on Political and Economic Systems, in Maastricht (Transparency in the Marketplace Summer School) and London (British Scholarship Trust scholarship for research work). She is employed as assistant at the Economics Faculty, Zagreb (Macroeconomics and Economic Development Department). She shares the teaching load for Macroeconomics, the Economy of Croatia and Economic History. The areas of her particular research interest are governance, institutional economics and economic growth.

Alida Ban, received her first degree from the Law Faculty in Zagreb in 1999, after which she took another undergraduate degree in the Faculty of Political Sciences in Zagreb, 2002, in the political science course. She is now completing the post-graduate course “Croatia and Europe” at the Faculty of Political Sciences. She is currently also employed as an associate in a law firm. Because of her marked interest in environmental law, for the last 3 years she has been working at the Ministry of Environmental Protection and Physical Planning on various projects, as domestic legal expert, on matters concerning the analysis of the degree to which Croatian regulations are harmonised with the relevant EU rules in the domain of environmental protection

Predrag Bejaković, took his doctorate at the Economics Faculty in Zagreb, and now works in the Institute of Public Finance, Zagreb. He was a Kingdom of Denmark scholar in Copenhagen, won a Fulbright to the University of Wisconsin at Madison, and was a British Council scholar at Essex and Bath universities. He has taken part in a number of projects, such as The Underground Economy in the Republic of Croatia, The Development of the Tax Administration in Croatia and Pensions Reform and a Sustainable Budget of the Institute of Public Finance, and The Employment Policy Programme of the Government of the Republic of Croatia. He publishes in scientific and professional journals such as *Financijske teorija i praksa* and *Časopis za društvena istraživanja*. He is co-author of a number of books from the areas of the economy, public finance and labour economics.

Ana-Maria Boromisa, took her first degree at the Electrical Engineering Faculty in Zagreb, and took a master's in European Studies, College of Europe, Natolin, Poland. Since 2001 she has been a member of the Croatian Energy Regulatory Council, where she is currently employed. Previously she worked in the Institute for International Relations and in Zagreb Airport. She has written many articles published in Croatian and foreign publications; the areas of her professional interest include the enlargement of the EU to the states of Central and Eastern Europe, particularly the economic criteria for accession, sectoral reform in the applicant states, and the possible effects of the enlargement of the EU on the states of SE Europe.

Judita Cuculić, took a master's at the London School of Economics in 2000, after taking a first degree at the Economics Faculty in Zagreb in 1999. She works as an economist in the IMF office in Zagreb, previously having been employed in the Ministry for European Integration and the Integration Strategy Office. Her areas of professional interest include the economic effects of the enlargement of the EU on exiting and new member states, with a special emphasis on fiscal aspects.

Michael Faulend, took his first degree and master's degree in international economics at the Faculty of Economics in Zagreb. He works as an advisor in the research department of the Croatian National Bank. He worked as an assistant to the executive director, International Monetary Fund, Washington D.C. and as an economist in the research department of Croatian National Bank. He is the author (or co-author) of several books and papers. His fields of interest are fiscal policy, the unofficial economy, corruption, monetary systems and problems in transition economies (dollarization, arrears, etc.).

Aida Liha, took her first degree at Zagreb's Economics Faculty, and her master's in European studies at the College of Europe, Natolin, Poland (2000). She is currently employed as researcher in the European Integration Department of the Institute for International Relations, Zagreb. Previously she worked in the Research Department of the European Parliament in Brussels and took part in an investigative project for the Economic and Monetary Policy Committee. Her areas of interest are institutional matters in the EU, and economic and social aspects of the enlargement of the EU to the states of Central and Eastern Europe and the states of the Western Balkans.

Dubravko Mihaljek, Senior Economist in the Bank for International Settlements (BIS) in Basel. He prepares analyses of economic trends and economic policy in the emerging markets in Asia, Latin America and Central and Eastern Europe for the governors and other officials of the central banks of BIS members. He was an IMF economist in Washington from 1990-99 (Asian, European and Fiscal Departments). He started his professional career in 1982 as assistant in the Economics Institute in Zagreb. He received his doctorate in economics at Pittsburgh University in 1990, having taken a master's at the University of Minnesota in 1986, and a first degree at the Foreign Trade Faculty, Zagreb, 1981. At Minnesota and Pittsburgh he was engaged in undergraduate teaching. He has been an advisor to the World Bank (1988-89) and the Government of the Republic of Croatia (2001). He has written over 70 papers in macroeconomics, fiscal theory and policy, monetary and exchange rate policy, economic development and banking.

Katarina Ott, is director of the Institute of Public Finance, editor of the journal *Financijska teorija i praksa*, trustee of the Prof. Dr. Marijan Hanzeković Foundation, and associate professor at the Economics Faculty in Zagreb, teaching in the post-graduate course Fiscal Federalism. She heads projects and publishes papers and books in the wider area of public sector economics. Her main area of interest is the relationship between government and the economy, above all the underground economy, the budget, public sector reform, local finances and in particular public sector transparency, government accountability and citizen participation.

Rüdiger Pintar, studied economics and sociology at the universities of Cologne and Munich, graduated in 1969 at the University of Cologne. He was employed at an institute for social research at the same university, dealing with research on occupational retraining programmes and the labour market. 1974, Ph.D. in economics and social sciences at the University of Cologne. Since 1978 employed with the Friedrich Ebert Stiftung (FES): 1978-1984 in Tanzania as adviser to the Ministry of Manpower Development in Dar es Salaam; 1984-1988 working at the headquarter of FES, in charge of projects in Eastern and South Africa; 1988-1992 representative of FES in Tunisia and Algeria; 1992-1999 again back at the headquarter of FES, responsible for proj-

ects in South-Eastern Europe; since 2000 head of the regional office of FES in Zagreb, in charge of projects in Croatia and Bosnia and Herzegovina.

Darko Polšek, took his master's degree (philosophy) and DSc (sociology of science) at the Faculty of Philosophy in Zagreb. He works as an associate professor at the School of Law in Zagreb where he teaches courses in general sociology and as scientific consultant at the Institute for Social Sciences in Zagreb. He was granted DAAD, Austrian OAD, Fulbright, and Oxford University scholarships. From March 2000 to July 2001 he was the Deputy Minister of Science and Technology of the Croatian Government, in charge of Higher Education. Recently, he was appointed an expert to the High Level Expert Group of the European Commission (Brussels) for Converging Technologies and Foresight. He was the Project Manager of the MBA School of Indiana University in Zagreb, a member of the Presidency of the Croatian Philosophical Society, the Presidency of the Croatian Sociological Society and was a director of the Zagreb office of the Friedrich Naumann German Liberal Foundation. He is the President of Sociological Department of the NGO Matrix Croatica, and one of the course directors of the international seminar "Social Aspects of the Sciences" at the Interuniversity Centre, Dubrovnik. He is the author of ten books, has edited several publications and has been a member of the editorial boards of four journals.

Ivan Rimac, took his first degree at the Faculty of Philosophy, psychology course, in 1984. From 1986 to 1992 he worked in the Institute for Social Research of the University of Zagreb on projects of educational sociology and youth sociology, and a number of applied research projects in demography, political attitudes and the media. In 1992 he took a master's with a dissertation from the area of cognitive psychology at the Faculty of Philosophy, Zagreb. Since that year he has worked in the Ivo Pilar Social Sciences Institute (formerly Institute for Applied Social Research) as associate in the public opinion project. In 1999 he took a doctorate with a dissertation on Basic psychological determinants of the formation of political preferences. In the same year he became a member of the European Values Study team. Since 2002 he has been running the scientific project "Psycho-social aspects of political behaviour." At the same time as his research activities, he

teaches the topics of statistical methods in psychology, statistics in social sciences, measurement theory, multivariate methods and political psychology in the Croatian Studies Course in the psychology and sociology departments

Vedran Šošić, took his degree at the Faculty of Economics in Zagreb. He works as an economist at the research department of the Croatian National Bank and as a teaching assistant at the Faculty of Economics in Zagreb (labour economics). He has consulting experience with the Government Office for Social Partnership (reform of labour market regulation) and has participated on the Human Development Report – Croatia 2002, the Institute of Economics, Zagreb and UNDP. He is the author of several books and papers. His fields of interests are labour markets in transition, monetary systems and problems in transition economies (dollarization, barter and arrears) and the unofficial economy.

Aleksandar Štulhofer, is an associate professor of sociology at the Faculty of Philosophy, University of Zagreb, where he teaches the sociology of culture and the sociology of sexuality. He has published more than seventy scientific papers and a number of books.

Alan Uzelac, took degrees in law, philosophy and comparative literature at the University of Zagreb. He did post-graduate work in Mainz and Vienna, and took master's and doctoral degrees at the Law Faculty in Zagreb, where he is today an associate professor at the Department of Civil Procedural Law. He was a Fulbright scholar during his research period at Harvard University. He has published two books and several dozen papers at home and abroad. He has taken part in a number of domestic and international research projects and lectured at a large number of scientific and professional conferences, some of which he has also organised. He has been editor of the magazine *Croatian Arbitration Yearbook* and the *Review of Arbitration in Central and*

Eastern Europe. He is a member of several international and domestic associations and working groups, has worked as international and/or local expert and consultant on several projects and missions of various organisations (CoE, UN, European Commission, World Bank). In 2003/04 he was a member of the Bureau of the European Commission for Efficiency of Justice (CEPEJ). His professional areas of interest include matters of organisational procedural law, theories of evidence and alternative matters of the resolution of disputes.
